And if you're carrying or shipping anything that might be considered Dangerous Goods — like oxygen bottles, lithium batteries, firearms, or chemicals — please let us know ahead of time. These require special handling and may not be permitted onboard or into the country.

It's all part of good travel prep — and just common sense. Since we're not the ones issuing permits or enforcing border rules, we can't be held responsible for any consequences if you or your items are denied entry or delayed upon arrival.

- Firearms, ammunition, replicas
- Flammable or corrosive substances
- Toxic chemicals or oxidizers
- Radioactive or magnetized materials
- Biological specimens or infectious substances
